And say THANK YOU for their support of the substance abuse fund (amendment #585) during Senate budget debate last week.

The Senate adopted a redraft of amendment EHS #585 to include \$2 million in line item 1595-4510 for the substance abuse services fund. The amendment also includes language allowing EOHHS to spend up to \$10 million in deficit as needed to fund all existing services.

# EOHHS has assured ABH they are confident they can maintain existing services with this funding and language.

The Senate President and House Speaker will now make appointments to a conference committee to resolve differences between the House and Senate spending bills and produce a final legislative budget known as a conference committee report.

The conference committee report will be voted either up or down (no amendments are permitted) by each chamber, and if approved, sent to the Governor who will have ten days to review the budget and return his vetoes and recommendations for amendment.

### **MCPAP for Moms**

In the past, you may have heard us discuss MCPAP, the Massachusetts Child Psychiatry Access Project, a program where pediatricians can access psychiatric consultations. Today, we want to let you know about MCPAP for Moms, a program that enables providers to call for a perinatal psychiatric consultation for pregnant and/or nursing mothers. MCAP for Moms, which is funded by the Department of Mental Health and administered by the Massachusetts Behavioral Health Partnership (MBHP) provides "real-time, perinatal psychiatric



consultation and care coordination for obstetric, pediatric, primary care and psychiatric providers to effectively prevent, identify, and manage depression and other mental health concerns in pregnant and postpartum women." Providers can call with medication questions, regardless of the diagnosis, but can also get assistance finding support groups and other resources for pregnant and nursing moms.

# Free Medicine and Supplies for Behavioral Health Provider Organizations

Please join us on June 14, 2016 from 1:30 p.m. to 2:30 p.m. for a webinar with Ameri-Cares, a global health and emergency response organization. Its U.S. Program is the leading provider of donated medicine, vaccines, medical supplies, and hygiene products to the U.S. health care safety net. AmeriCares product donations are complemented with educational resources and targeted initiatives that build capacity in health organizations across the country. The program has a network of more than 900 partners in all 50 states that serve over 5 million patients per year. AmeriCares is licensed as a wholesaler to distribute pharmaceutical products and medical supplies in all 50 states, and all donated products are provided at no cost for distribution to low-income, uninsured, and underinsured patients.



## Chapter 257 Update

Staff from the Executive Office of Health and Human Services recently gave a presentation to the Chapter 257 Provider-Consumer Advisory Council (PCAC) concerning ongoing implementation of *Chapter 257*.

The presentation includes updates on rate-setting activities under *Chapter 257* in accordance with the legal settlement *The Collaborative* signed with EOHHS last year. It lists finalized regulations, publically proposed regulations,



regulations that are in the "pipeline", and rate reviews that are scheduled to be completed in FY 2017. The presentation also reviews FY 2016 rate increases.

#### **SAMHSA NARCAN Grant**

DPH/BSAS is applying for a SAMHSA Cooperative Agreement Grant to Prevent Prescription Drug/Opioid Overdose-Related Deaths, and seeks to partner with agencies that offer a continuum of care for addiction treatment licensed and funded by BSAS including Acute Treatment Services, Clinical Stabilization Services, Transitional Support Services, Opioid Treatment Programs, and Residential Treatment Services.

This Cooperative Agreement will be funded for five years and BSAS plans to work with 2-3 partner agencies in the first year of the grant to implement broad pharmacy-access to naloxone. Additional partners will be included in subsequent years of the grant. A process for the selection of partners to participate in the first and second years will be determined at the time of award of the SAMHSA grant.

For the grant, BSAS will propose to focus on four major areas of effort:

- I. Implementing an innovative model for naloxone access for individuals in addiction treatment dispensed from pharmacies and billed to their insurance;
- 2. Implementing agency-specific standing orders, or other strategy for staff training and naloxone access to equip programs for on-site emergency response in a wide range of agencies serving individuals who are at-risk of experiencing an opioid overdose;
- 3. Providing training and training materials on overdose prevention and response, including naloxone, through a variety of accessible venues and formats statewide; and,
- 4. Partnering with the Division of Insurance, the Board of Registration in Pharmacy, the DPH Drug Control Program and other stakeholders on policies that ease pharmacy-access to naloxone and implementation of models that remove barriers to access.
