## Commonwealth v. Julie Eldred

ABH recently signed onto an Amicus Brief concerning a case in which a woman in Massachusetts had her probation revoked because she violated a District Court order to "remain drug free." The woman was placed on probation for a larceny charge, but after testing positive for the opioid fentanyl, she was incarcerated at MCI Framingham.

ABH and other groups and individuals, including The Massachusetts Medical Society, The American Academy of Addiction Psychiatry, and the Massachusetts Organization for Addiction Recovery (MOAR) have filed the brief ascertaining that addiction is a brain disorder and therefore, the court's decision to incarcerate the woman in question for relapsing was inappropriate. ## Policy Team in Action

The ABH policy team has been working to ensure that the interests of ABH's member organizations are represented before the Massachusetts Legislature. Recently, ABH submitted testimony in opposition to H. 3593, *An Act to Prevent Oversaturation of Clinical or Educational Programs in Low Income Neighborhoods under the Dover Amendment without Local Approval*. ABH argued that the legislation would be discriminatory against individuals with a recognized medical illness, thereby violating the *Americans with Disabilities Act of 1990 (ADA)*. The legislation would deny treatment facilities the benefit of having municipalities make zoning decisions without regard to the disabilities of clients who are disabled within the meaning of the ADA.

ABH also testified in favor of S. 525/H. 486, *An Act to Require Health Care Coverage for the Emergency Psychiatric Services*. This legislation requires commercial insurers to cover emergency psychiatric services, called Emergency Service Programs (ESPs), a benefit the Commonwealth currently funds for all MassHealth members. The state has determined the ESP service is vitally important to the behavioral health continuum of care and ABH believes it is imperative all insured individuals have access to the same benefits.

## Graham-Cassidy Vote Pulled from Schedule

As you may have heard, the Senate will not be voting on the Graham-Cassidy health care bill. Republicans in Congress have once again abandoned their attempts to decimate Medicaid and repeal the Affordable Care Act.

### **THANK YOU for your advocacy and support!**

ABH and the National Council will continue to keep you updated on any further information at the federal level. As you may know, Republican leadership in the Senate have until September 30th to pass legislation with only 50 votes through the annual budget reconciliation process. Once this deadline passes, the filibuster in the Senate requires 60 votes to enact this legislation. This deadline had helped fuel the momentum of those opposed to the ACA for another attempt at repeal.

Although the threat of repeal has subsided again, we do expect Republican Congressional leadership to continue to attempt to change the structure and financing of federal health care moving forward.

## Hear Ye, Hear Ye



A public hearing for proposed rate amendments for Youth Intermediate-Term Stabilization services (Including Group Home 1:3, Group Home 1:4, Pre-independent Living, STARR, Youth Residential Substance Use Disorder Treatment, Continuum, Follow Along and Stepping Out services) has been scheduled for Friday, October 13, 2017, at 10:00 a.m. in the First Floor Conference Room, 100 Hancock Street, Quincy, MA.

Written comments are due by 5:00 p.m. on Friday, October 20th, 2017.

The proposed amendments update rates for Youth Intermediate-term Stabilization services to include an increase by a cost adjustment factor (CAF) of 2.72% for January 2018 through December 2019. This proposed amended regulation is planned to go into effect no sooner than January 1, 2018.
