Members registering for the conference by Friday, September 9th will only pay \$575. The following is the schedule of registration fees based on specific deadlines moving forward:


- Register before Sept. 9: \$575 instead of \$775

Serving Marginalized Populations

In an effort to better meet the needs of our membership, ABH is establishing a new committee tentatively called the **Serving Marginalized Populations Committee**. ABH has created this committee in response to feedback from our member organizations who serve populations who have been traditionally marginalized in our health care system and in broader society. The committee will meet every other month and will focus on best practice service delivery of mental health and addiction treatment services for the people and communities of the Commonwealth who face systemic, cultural, ethnic, racial, linguistic, and LGBTQIA disparities. This committee will provide a forum for program directors and staff to share best practices and discuss challenges in providing services to the local populations traditionally marginalized in the health care system.

This new committee will be staffed by Kristen Archibald, Director of Children's Behavioral Health and Member Services at ABH and Co-Chaired by two members of ABH's Board of Directors: Henry East-Trou, Executive Director at Gandara Mental Health Center and Emily Stewart, Executive Director at Casa Esperanza.

The Committee will meet on the second Monday afternoon of every ODD-numbered month from 1:00-3:00 p.m. at either ABH Offices (251 West Central St., Suite 21, Natick) or Hampton Inn (319 Speen St, Natick) pending depth of membership attendance. The meeting dates for FY17 are:

Co-pays Eliminated for Addiction Treatment

Over the summer the Massachusetts Health Connector voted to eliminate copayments for medication assisted treatment. This means that, starting next year, individuals who are insured by a Connector plan will no longer have to pay co-pays for Methadone or Suboxone treatment or the associated counseling. The Connector also voted to eliminate co-payments for Narcan and other drugs that reverse overdoses. For more information, contact Mandy Gilman at AGilman@ABHmass.org.
