#### **House Budget Passed**

On April 27, the Massachusetts House of Representatives voted unanimously to pass a \$49.7B fiscal 2023 budget, adding nearly \$130M in spending to the original House Committee on Ways and Means proposed budget. Some highlights from the amendment process include:

- \$3M in technical assistance and training to increase the number of providers delivering culturally, ethnically and linguistically diverse substance use services in communities of color, a Massachusetts Coalition on Addiction Service request;
- Prior appropriations from FY22 continued into FY23 for the procurement of Recovery Centers and outpatient/mobile services for deaf/hard of hearing and blind individuals with substance use disorders, a Massachusetts Coalition on Addiction Service request;
- Requiring the Health Policy Commission to conduct an analysis and issue a report on behavioral health boarding in hospitals; and
- Requiring the Department of Public Health to annually examine and report on the prescribing and treatment history, including court-ordered treatment or treatment within the criminal legal system, of individuals who suffered fatal overdoses in the Commonwealth.

Other highlights from the House budget:

- The Department of Mental Health (DMH) is funded at \$992M.
  - •The Adult Community Services line item (5046-0000) is funded at \$514M, consistent with H.2 and \$6.3M lower than projected FY22 spending.
  - •The Children's Services line item (5042-5000) is funded at \$111.8M, consistent with H.2. and approximately \$6.7M over projected FY22 spending.
  - •DCHD Rental Subsidies for DMH Clients is level funded at \$12.5 million, consistent with FY22 projected spend and ABH's requested funding amount.
- BSAS programmatic accounts are consolidated and funded at \$196M. This level of funding represents an increase of \$14M over H.2.

#### **Next Steps:**

Senate Ways and Means will release their budget in mid-May, with debate to follow. After each chamber has approved its version of the budget, the Senate President and House Speaker will make appointments to a conference committee to resolve differences between the House and Senate spending bills and produce a final legislative budget known as a conference committee report. The ABH's Committees, click conference committee report will be voted either up or down (no amendments are permitted) by each chamber, and if approved, sent to the Governor who will have ten days to review the budget and return his vetoes and recommendations for amendment..

#### William James College Invitation to Beyond Compassion Fatigue: Helping Caregivers Recover from Pandemic Burnout and Reconstruct Organizational Life

**Program Summary:** After two years of pandemic stress, many professional caregivers are beyond the point of burn-out. We face the task of helping those in human services recover from their fatigue, process the traumas of Covid-19, and reconstruct their organizations according to our new reality. This workshop engages participants in each aspect of recovery at the personal, group, and institutional levels. We will survey the research on compassion fatigue, burnout and secondary trauma, and explore effective resilience strategies for our current state.

The program is delivered in a highly interactive online format incorporating discussions, reflections, and experiential learning. Participants will reflect on their own experiences, share stories in small groups, and assess contextual factors within their organization.

Eligible participants are practitioners and supervisors with 2+ years of experience in human services (psychology, social work, nursing, therapy, etc.). Please note that participants are encouraged to share from personal experiences and may be exposed to triggering material.

### RFP Released: Middlesex County Restoration Center Pilot Program

Prospective bidders may need to scroll down to get to this procurement. The procurement includes a number of formal documents that can be downloaded separately or together.

The Restoration Center pilot program is intended to provide an entry point into appropriate Behavioral Health Services to individuals, 18 years old or older, who are experiencing a behavioral health crisis, especially as a diversion from criminal legal system involvement or ED utilization. The Commonwealth's long-term goal is to develop a successful Restoration Center model that multiple vendors can replicate across the state in future years.

#### **MassHealth Releases ACO RFR**

MassHealth has released its Request for Responses (RFR) for its Accountable Care Organization (ACO) Program. You can find the RFR on COMMBUYS. MassHealth is anticipating that its 1115 Waiver will be extended. This extension will continue the focus on accountable care delivery systems. According to MassHealth, "Under the new contracts, ACOs will further improve quality of care, reduce total cost of care, and make demonstrable progress towards improved member and provider experience....[and] enhance expectations for primary care and behavioral health delivery, increase focus on children, youth, and families, and create incentives to improve health equity."

## COVID-19 Public Health Emergency Order 2022-17 and Associated Advisory Expire on April 30, 2022

The MA Drug Control Program has issued a notice to remind all MAP-Registered Community Programs that COVID-19 Public Health Emergency Order 2022-17 and associated advisory, posted <a href="here">here</a>, will expire on April 30, 2022. As of May I, 2022, it is no longer permissible for unlicensed staff of MAP Community programs who are not MAP-Certified to possess and administer prepackaged medications to individuals in MAP-Registered Community Programs. Medications must be administered by licensed health care providers and MAP-Certified staff after April 30, 2022.
