The public hearing for the proposed rates will be held on **Friday**, **June 14**, **2024**, **at 10:00** a.m. This hearing will be conducted remotely. State Releases Opioid Related Overdose Report

The Department of Public Health released the latest Opioid Related Overdose Report on June 12, 2024. The report shows that overdose related deaths in Massachusetts decreased by 10% in 2023, but American Indian, and non-Hispanic black men and women continue to be disproportionately impacted. The state's most rural areas continue to record the highest rates of opioid related overdose deaths. Fentanyl was present in 90% of fatal opioid-related overdoses where toxicology reports were available.

Support and Stabilization RFR Deadline Extended

The Department of Children and Families (DCF) has notified Support and Stabilization (S&S) bidders that the procurement calendar for the S&S RFR will be amended. This is due to the cancellation of the public hearing for the new S&S rates. As a result, the bid submission date will be extended **beyond July 12th**. The amendments to the S&S RFR procurement calendar will include:

- Bid submission due date will be approximately four weeks AFTER the new public hearing date; and
- All remaining due dates will be extended accordingly.

The RFR will be amended with the revised dates after EOHHS announces the date for the new public hearing.

Analysis of the Senate Ways and Means Budget Proposal

On Tuesday, May 7, the Senate Committee on Ways and Means (SWM) released its recommendations for the Fiscal Year 2025 (FY25). The Committee recommends \$57.9 billion in spending, a \$1.8 billion increase over the FY24 final state budget.

The SWM budget proposal includes the following highlights:

Department of Mental Health (DMH)

- The Adult Community Services line item (5046-0000) is funded at \$622.3 million. This is consistent with the Governor's proposal, is \$3 million over the House budget, and is \$25.6 million increase compared to the FY24 final budget.
- The Children's Services line item (5042-5000) is funded at 130.5 million, including \$3.9 million for the Massachusetts Child Psychiatric Access Program (MCPAP) and MCPAP for Moms to address mental health needs of pregnant and postpartum women. This is consistent with the Governor's proposal, is \$460K below the House budget, and is an approximately \$9.9 million increase compared to the FY24 final budget.
- The Behavioral Health Outreach, Access, and Support Trust Fund line item (1595-4512) is recapitalized at \$20 million to support targeted behavioral health initiatives.

Department of Public Health (DPH)/Bureau of Substance Addiction Services

 The Bureau of Substance Addiction Services (BSAS) line item (4512-0200) is funded at \$197.9 million. This is approximately \$4.8 million over the Governor's proposal, and \$3.5 million over the House final budget. It is a \$18.7 million decrease compared to the FY24 final budget.

MassHealth

MassHealth is funded at approximately \$20.3 billion. This is consistent with the Governor's proposal and the House budget. It is a \$505.5 million increase compared to FY24 final budget.

Chapter 257 Rate Reserve (1599-6903)

- The Chapter 257 rate reserve is funded at \$390 million. This is consistent with the Governor's proposal and the House budget. It is a \$217 million increase compared to the FY24 final budget.
 - It should be noted that when H.2 was released the Administration messaged that an additional \$95 million supported by an off-budget reserve would bring the total FY25 investment to \$485 million. The FY22 Economic Development Bond bill increased the Bureau of Labor Statistics benchmark from the 50th to the 53rd percentile and included \$125 million on a reserve to fund this increase in FY24 and FY25. The messaging was that H.2 assumed \$95 million of this reserve will be used to offset the projected Chapter 257 need in FY25.

After each chamber has approved its version of the budget, the Senate President and House Speaker will make appointments to a conference committee to resolve differences between the House and Senate spending bills and produce a final legislative budget known as a conference committee report. The conference committee report will be voted either up or down (no amendments are permitted) by each chamber, and if approved, sent to the Governor who will have ten days to review the budget and return any vetoes and recommendations for amendment.
